## **Background**

USA Cheer is responsible for the growth and oversight of all disciplines of Cheer within the United States.

- Cheer has evolved into a highly skilled athletic activity, but also plays a unique role in schools.
- USA Cheer recognizes the importance of sportsmanship, and the impact that Cheer has in elevating spirit at games, within schools and in the community.
- Cheer is a critical part of the high school experience, and the spirit and leadership elements of the activity require a unique structure within the school.

Schools have adopted various disciplines of Cheer to uniquely support the needs of sports and activities within their schools.



## **Competitive Cheer Bill in California**

With the passing of the AB949 Competitive Cheerleading Bill, introduced by assembly woman Lorena Gonzales from the 80<sup>th</sup> district, the California Interscholastic Federation (CIF) now recognizes competitive cheer as an approved CIF sport with two different formats:

- 1. Traditional Competitive Cheer (TCC)
- 2. Competitive Sport Cheer (CSC)

One of the key objectives of the bill is to ensure that all competitive cheer coaches comply with CIF coaching certification and safety requirements.



### **Goals in California**

#### The objectives pertaining to cheer programs

- Ensure coaches have the best training and safety education available and that participants follow safety guidelines.
- 2. That cheer programs have the opportunity for athletic participation and recognition for their roles in leadership.

#### How can we achieve these goals?

- Create Awareness participation and safety
- 2. Create Opportunities, not limitations
- 3. Create competitive experiences and opportunities for all schools
- 4. Keep event expenses for schools minimal





Types of Cheer in California

Cheerleaders cheering for another athletic team at a school site athletic event (Game, match, meet, etc.)	Standard competition routine with <i>subjective</i> judging	Involves head to head competition with <i>objective</i> judging

# What does this mean for me and my team?

- ➤ If you're a Sideline only Cheer team, this does not affect you at all. Continue the important job raising spirit and school pride on your campus all year long!
- ➤ If you're a Traditional Competitive Cheer (TCC) or (CSC) competitive sport cheer team, you will have specific sport guidelines for the 2018-2019 season:
  - Must follow CIF safety standards, practice times and sport requirements
  - Adhere to the season of sport for TCC and or CSC.
- ➤ If you want to ADD a new varsity female sport to your high school (CSC) Competitive Sport Cheer is an option, and a great opportunity for high school females to participate in a Spring sport derived from cheerleading.



## How to be successful independently yet work cohesively together

## Game Day Preparation

➤ Summer camp, pep-rallies, school ambassadors, community relations and more — this is your sideline team — work with principal on adhering to club/activity requirements for this team.

## > Competition Preparation

Work with Athletic Director to define start date for your program with TCC



## Season of Sport

As we begin, **Traditional Sport Cheer** will not have a defined season of sport under CIF – however check with your section/district on timeline for TCC in your area. The **Competitive Sport Cheer** season of sport has been identified as a Spring sport.

- ➤ Competitive Sport Cheer (CSC) should all be current students- check with your section/district for recruiting rules and timeline




